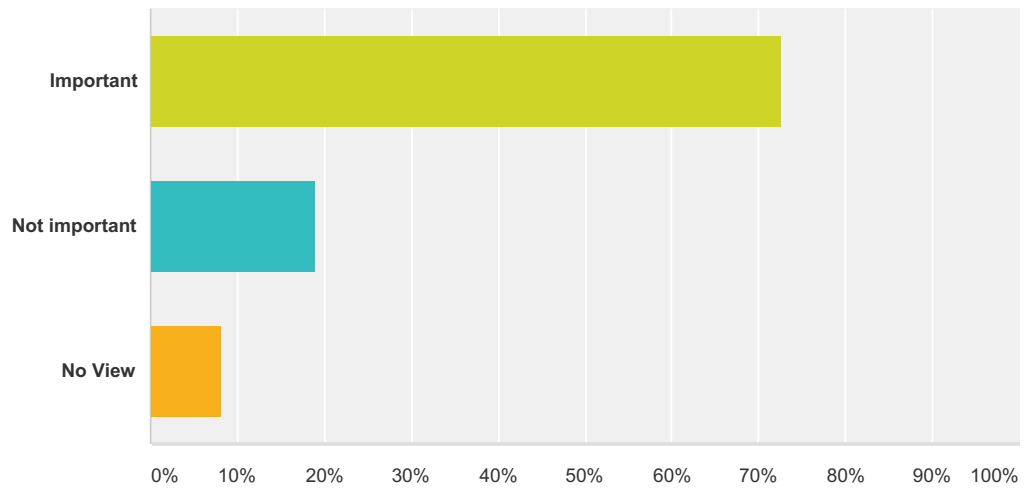

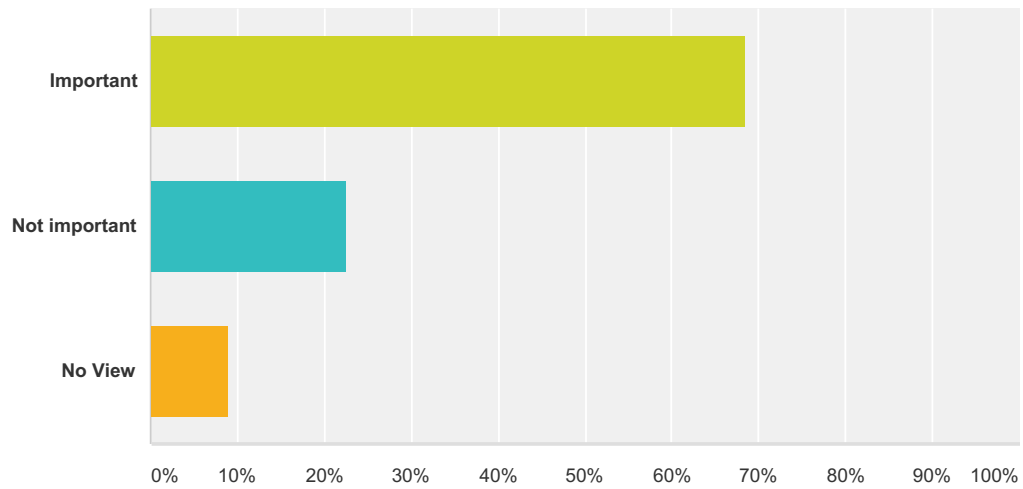

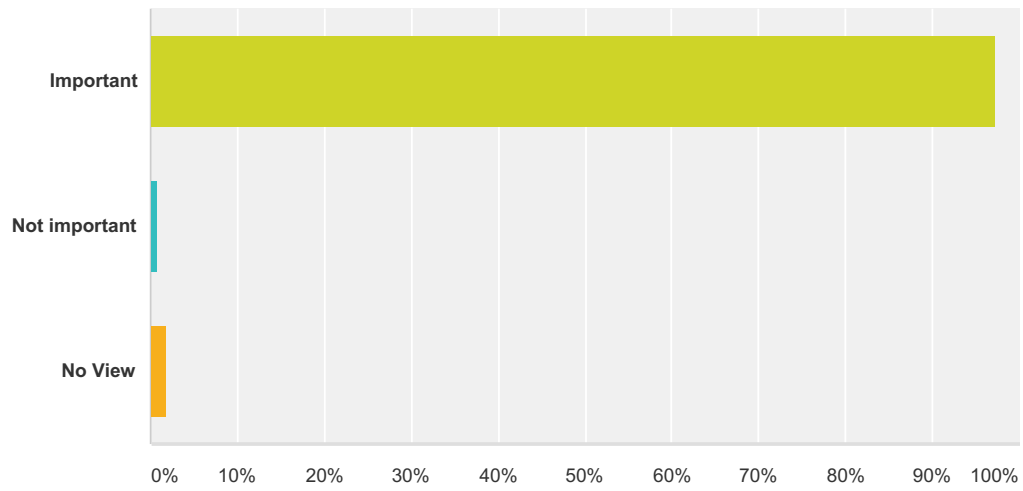

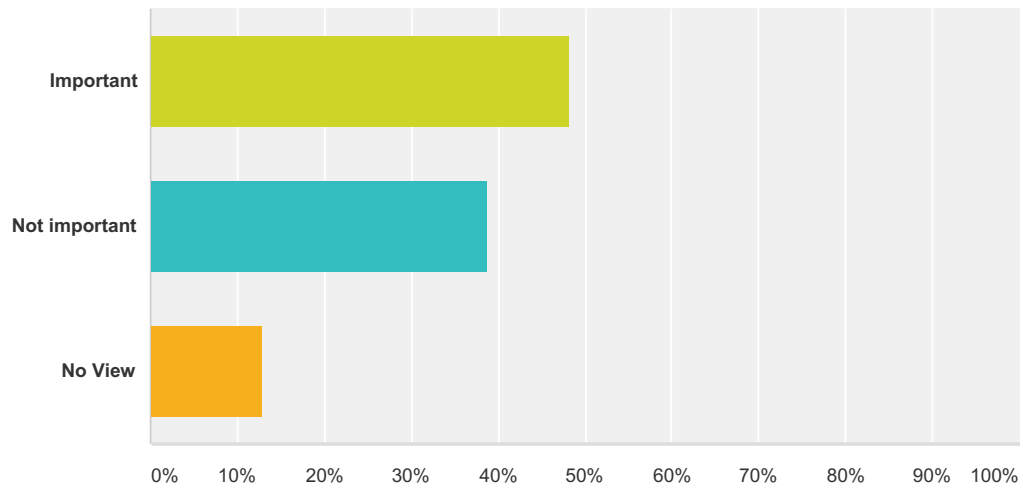

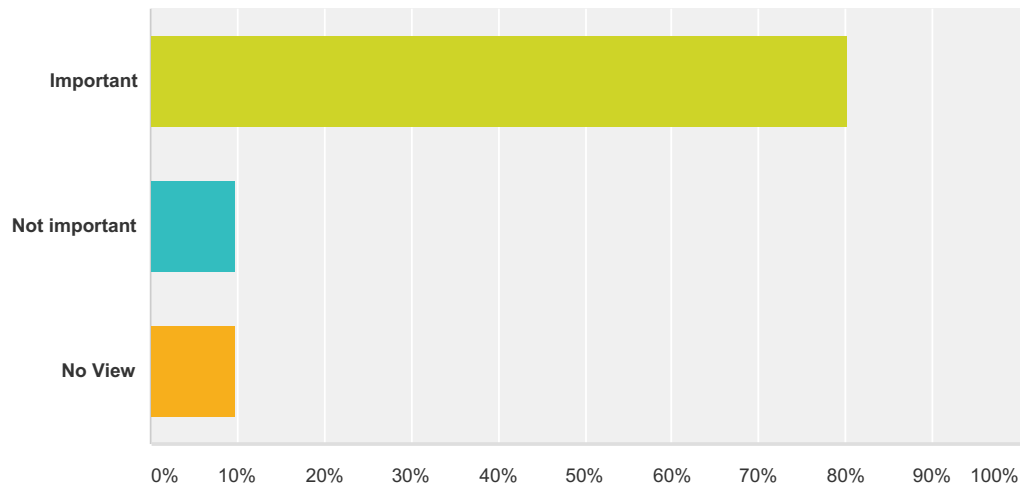

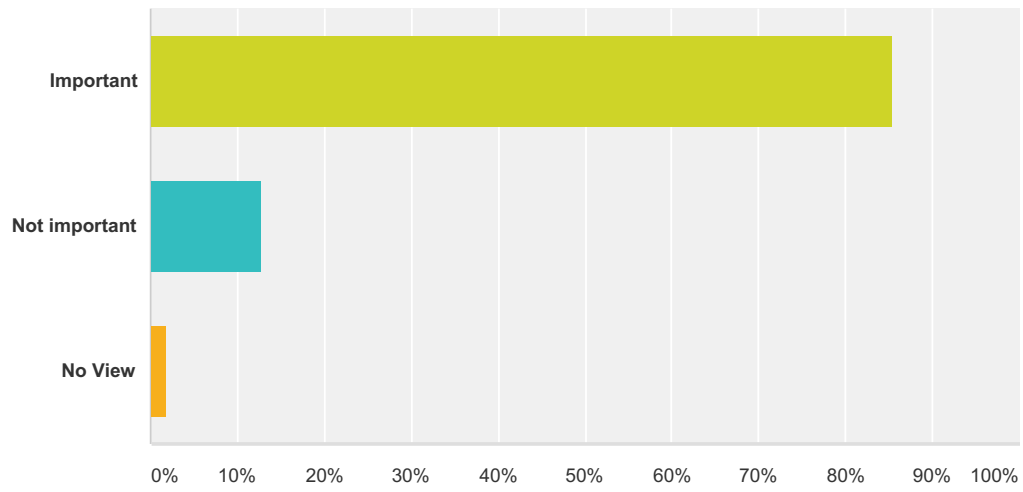

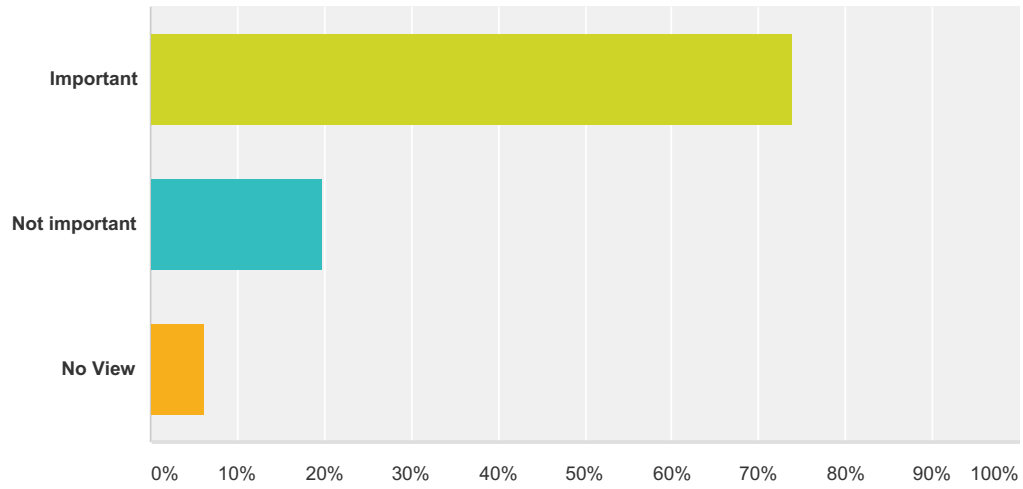

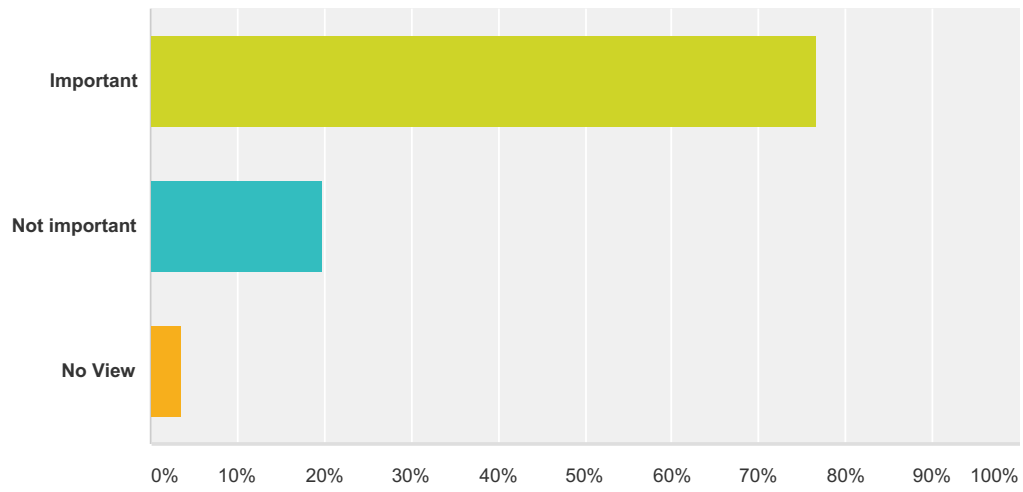

Q9 Health facilities & well being (Relocate doctors surgery)

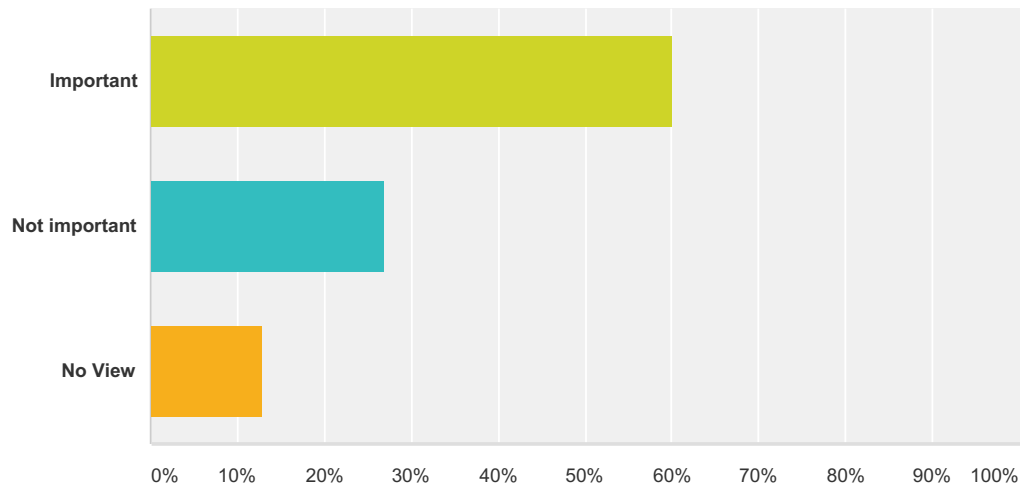

42	<p>We feel it is most important to maintain the Polruan heart of the village around the shops and quay. Building, a community hub at the tope of the village is likely to cause a decline in usage of the shops/café and quay area (Polruan). However a community facility with business units which encourages business opportunities will be more beneficial than a community hub on its own. Business units will bring in residents of working age who will often have families. These units would be of great interest to self employed people who require a facility that cannot be accommodated in their own homes. The use of these units by local artisans will also encourage a steady stream of visitors to the village, thus increasing usage of the shops and pubs. Any new building should harness renewable energy sources by using alternative power, such as solar panels and air source heat pumps. The doctors surgery could also be relocated to this facility, which would need adequate parking. With the excellent internet connection in the village, home working should be encouraged as part of the overall plan to attract more residents into the village. The village school is vital in attracting young families and without it there is a danger that the village will become a retirement community. As Polruan is isolated on a peninsular, the bus and ferry services are essential in maintaining transport links for both residents and visitors. I would keep the village hall in its present location so that it continues to host plays, meetings and events. 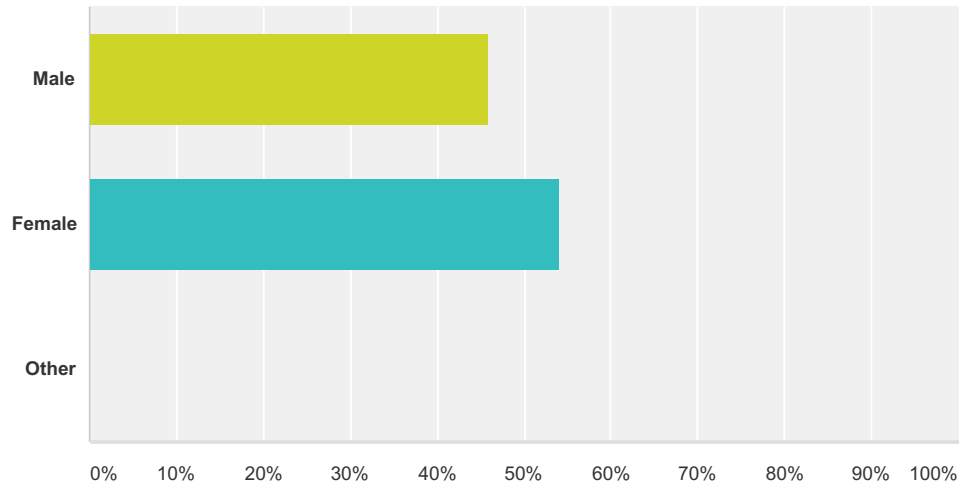

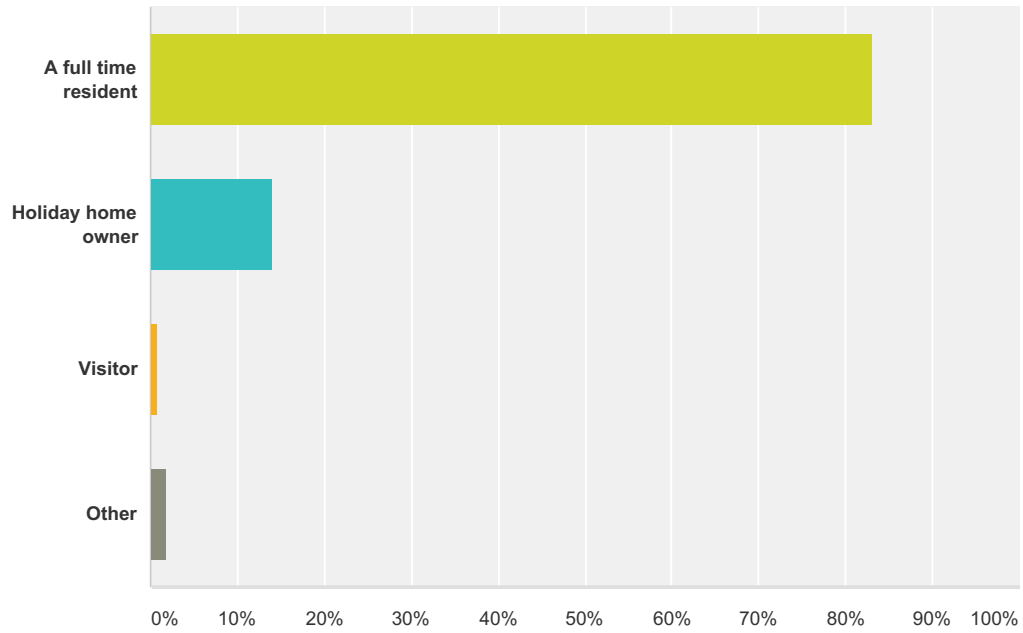

Q13 Are you:

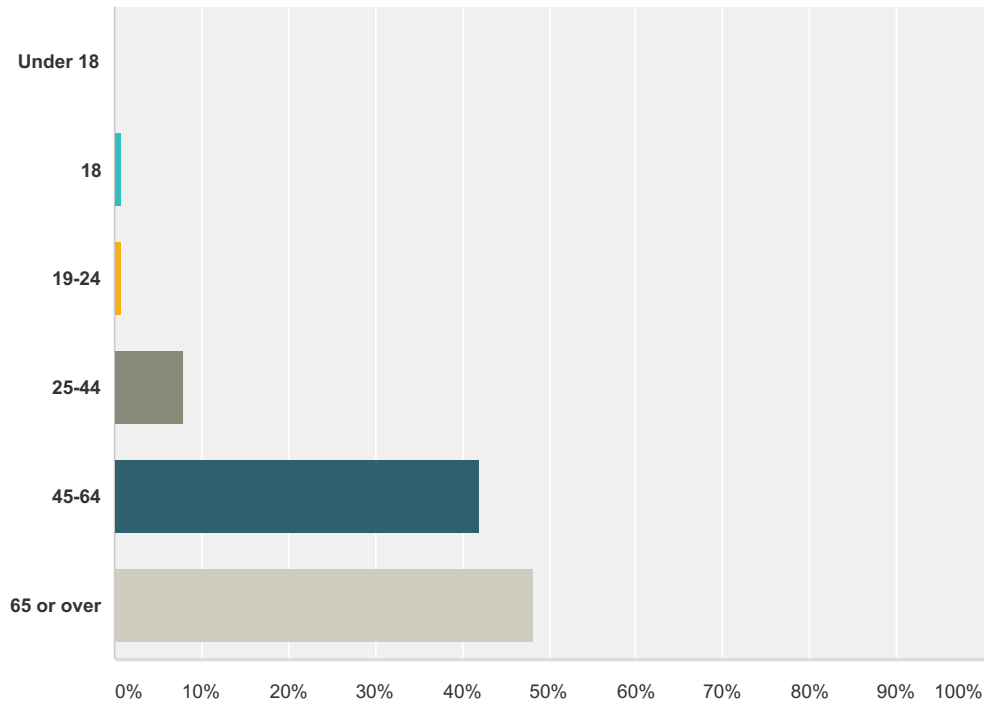
